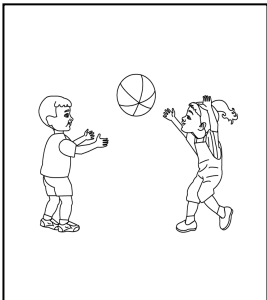

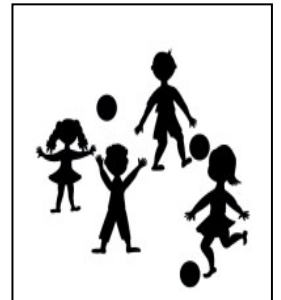

- We will **NOT** accept registration after May 31, 2018
(NO EXCEPTIONS)
- Field Trips are **NOT** included in the \$450.00 registration fee
- Upon registration, please provide proof of residency and a copy of the child's birth certificate
- **NO** refunds will be issued once camp begins
- You must pay a \$6.00 insurance fee per child, each year
