### 7-15.1C Parking Decals.

- a. Residents of the City of Linden shall be issued **decals** which would permit them to park their motor vehicles from 6:00 p.m. to 7:00 a.m. on Monday through Sunday, including legal holidays.
- b. **Decals** will be issued by the Municipal Police Department, upon submission of automobile registration, to the residents residing in the various homes affected by the **parking** problems. **Decal** is to be displayed on the left rear side window.
- c. The issuance of a **parking decal** shall not relieve the owner of the **decal** from complying with all other **parking** regulations; i.e. street sweeping, **parking** in bus stops and other ordinances.
- d. The streets affected by this section are as follows:

*Academy Terrace*, north side, from N. Stiles Street to a point 225 feet west of the westerly curblines of Deerfield Terrace

*Andover Road*, west side, from Exeter Road to Kent Place.

*Debra Drive*, west side, from Karen Terrace to Donna Court

*Debra Drive*, east side, from Karen Terrace to the projection of the easterly curblines of Donna Court

*Donna Court*, both sides, from Karen Terrace to Debra Drive.

*Karen Terrace*, north side, from Debra Drive to Donna Court.

*Karen Terrace*, south side, from Donna Court to N. Stiles Street

*Kent Place*, south side, from the projection of the easterly curblines of Kent Circle to a point 225 feet west of the westerly curblines of Deerfield Terrace.

*Kent Place*, north side, from Kent Circle to Andover Road.
